Copies of most books, manuscripts, microforms, and photographs in the U.S. Army Military History Institute can be provided for a fee. All reproduction orders placed by the public must be prepaid by check or money order and **made payable to: MHI Fund**. Payment cannot be made with cash, stamps, or checks drawn on foreign banks. Payment for foreign patrons must be made using U.S. currency and in a form that will clear through U.S. banks. Patrons who have checks returned for insufficient funds will be charged a \$25.00 processing fee in addition to the cost of the original order. Send copy orders to:

Please note that there has been an increase in prices due to Army budget cuts.

Photocopying Fees

Photocopies of books, manuscripts, and microforms are \$0.50 per page for off-site patrons and on-site patrons for whom MHI staff does the copying. The fee for on-site self-service copying is \$0.25 per copy.

There is a minimum charge of \$20.00 plus \$15.00 processing & handling fee for photocopying of books, manuscripts, and microforms. There is no minimum charge for photocopies of still images.

Photocopies of oversized materials are \$1.00 per copy.

Photocopies of photographs are \$1.00 per copy.

Copying fees are usually waived for official users acting in the line of duty for normal and customary requests.

Rush Orders

Within 3 working days (upon receipt of payment) 100% surcharge of total

Within 1 working day (upon receipt of payment) 200% surcharge of total

NOTE: Rush orders are processed upon receipt of payment within the requested time period and placed in the U.S. Mail stream via 1st Class Mail (unless you want to provide MHI with your overnight service account number).
